Pete Buttigieg <input type="radio"/>	The estimated millage that will be levied for the proposed bonds in 2021, under current law, is 1.60 mills (\$1.60 on each \$1,000 of taxable valuation). The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-two (22) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 2.29 mills (\$2.29 on each \$1,000 of taxable valuation).

The total amount of qualified bonds currently outstanding is \$3,990,000. The total amount of qualified loans currently outstanding is \$-0-. The estimated computed millage rate may change based on changes in certain circumstances.
