PLEASE TAKE THE TIME TO READ THIS: IT IS FOR YOUR INFORMATION!!!

The property owners in this area are planning to have the waters in this area chemically treated for control of lake weeds and/or algae. This notice is being circulated at least 7 days in advance of the treatment in accordance with Department of Natural Resources procedures. A permit for the treatment has either been secured or will be secured from the DNR before the work is begun.

We treat each lake according to a schedule or season plan worked out with either your lake association, lake board or residents on the lakes and prior reviews. Due to the uncertainty of weather please watch your shoreline for the posting of the 14X11 inch yellow signs, particularly in May and early June. The signs will indicate the date of the treatment, the chemicals used, and the restrictions as to the use of the water for swimming, watering lawns, and the consumption of fish taken from these waters.

In the event that you see us spraying and signs are not posted you will know we have not treated your area or any area in which restrictions will be applied to your property.

We anticipate using one or more of the chemicals listed below. Please read the restrictions. Again, these restrictions with their respective chemicals will be found on the restriction signs on day of treatment.

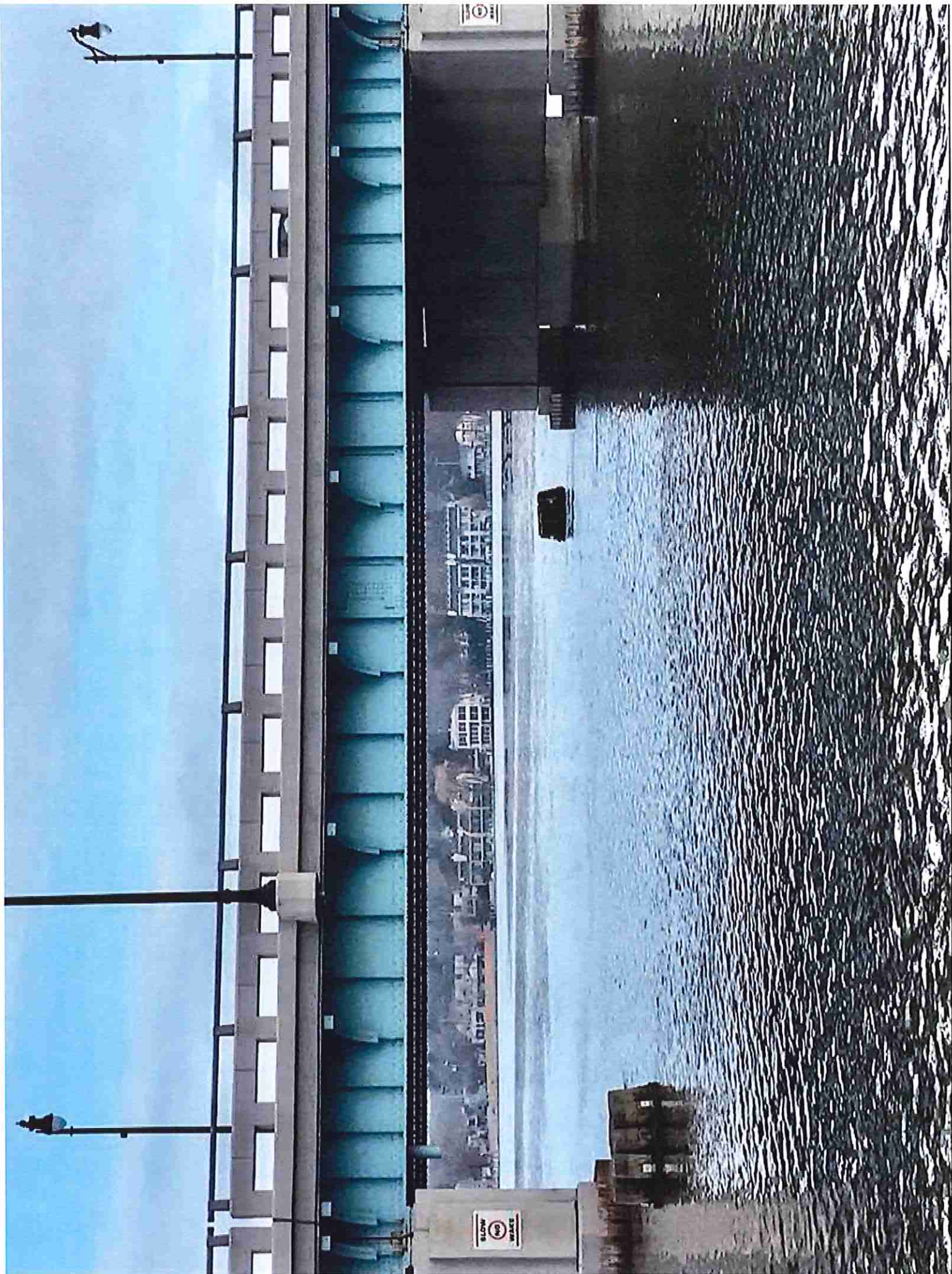

Diquat	Swimming or bathing: 1 day Household uses, non-crop irrigation, livestock watering: 3 days Fish consumption: 0 days
2,4-D	Swimming or bathing: 1 day Household uses, non-crop irrigation, livestock watering: 3 weeks (Post "indefinite" per DNR ruling) Fish consumption: 0 days
Triclopyr	Swimming or bathing: 1 day Household uses, non-crop irrigation, livestock watering: 120 days Fish consumption: 0 day
Aquathol K Hydrothol 191	Swimming or bathing: 1 day Household uses, non-crop irrigation, livestock watering: 0 days Fish consumption: 0 days
Copper Sulfate Chelated Copper	No restrictions

When more than one chemical is used the strictest, longest limits will be posted. These restrictions are designed to allow the safe use of these chemicals. Please do not encourage anyone to use the waters while these restrictions apply.

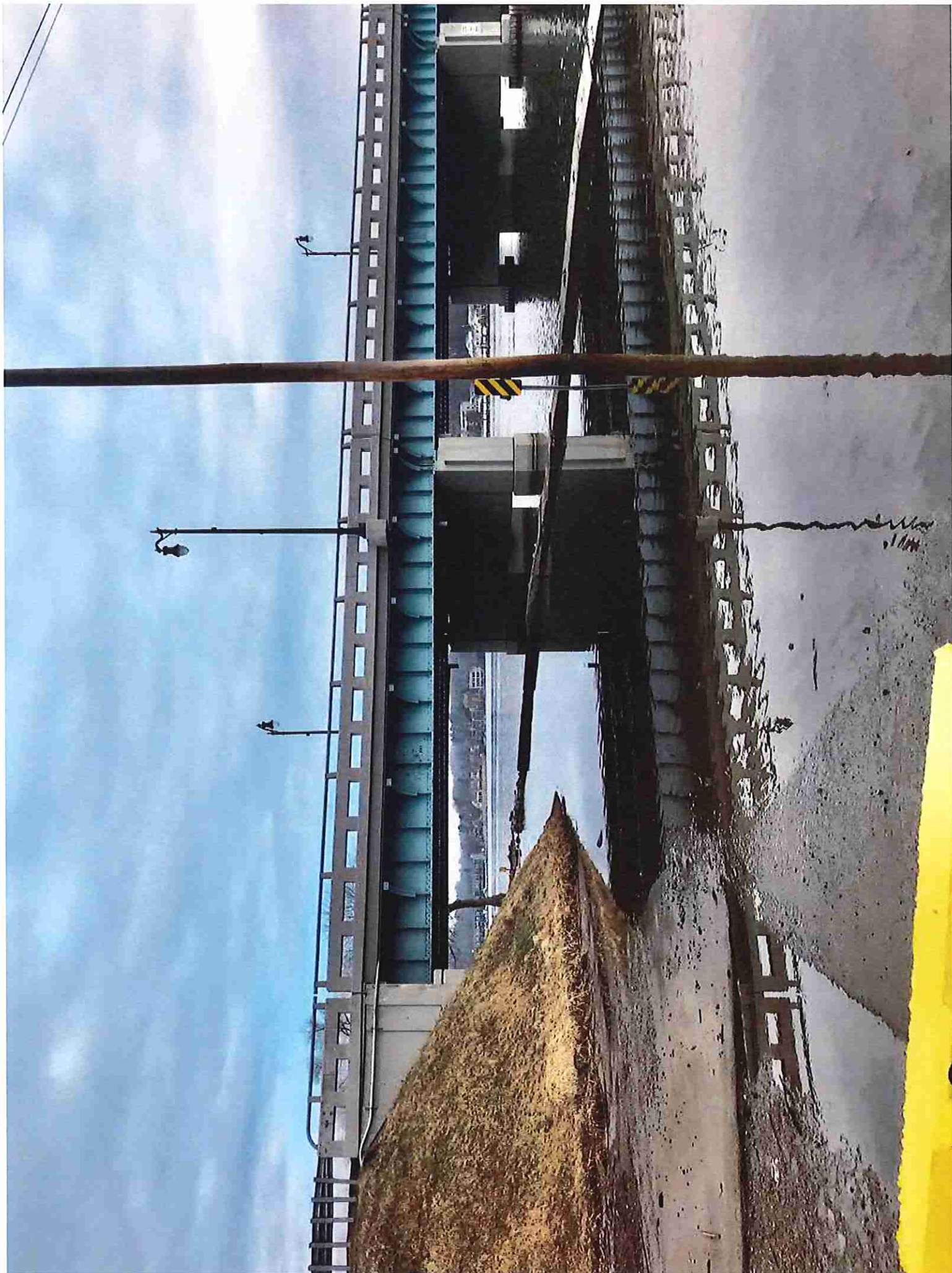

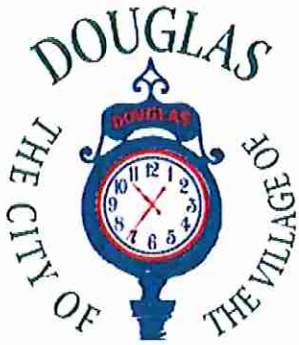

Subject: Navigation Buoy and Anchor
Installment / Removal
Services Contract

The City of Douglas seeks to award a three-year contract for the installment and removal of the Douglas Harbor navigational buoys and anchors. The qualified contractor shall be licensed and insured and will have the responsibility to install buoys and anchors around mid-May on a date coordinated with the contractor and the Director of the Department of Public Works. Removal of said buoys and anchors shall be completed by mid-November every year and placed in a location available to the Department of Public Works for retrieval and storage.

It is the intent of the City of Douglas to award the contract to the most advantageous regarding price, quality of service, the vendor's qualifications and capabilities to provide the specified service, and other factors which the City of Douglas may consider.

The following responses were received from two vendors interested in performing the work:

Boat Lifts Unlimited, Holland -	\$70 per buoy (approx. 20 buoys) for 2020 season (\$1400 total)
	\$70 per buoy (approx. 20 buoys) for 2021 season (\$1400 total)
	\$75 per buoy (approx. 20 buoys) for 2022 season (\$1500 total)
Old Harbor Marine, Saugatuck -	\$185 per hour (in 2019 the City paid \$2500 for barge rental and operator for the spring installation)

A recommendation from the Douglas Harbor Authority and the Kalamazoo Lake Harbor Authority was not requested because the cost of this service falls within the City Manager's administrative authority; however, City Council has to approve the award of all contracts on behalf of the City. The City of Saugatuck also uses Boat Lifts Unlimited for their annual buoy installation and removal services.

Funding for this activity is budgeted in the Douglas Marina Fund's "Contractual" activity - 594-599-802.

I recommend that City Council award Boat Lifts Unlimited of Holland, MI, a contract for a term of three years to provide the annual navigational buoy and anchor installation and removal services

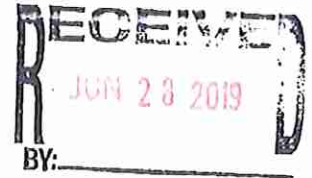
