**A RESOLUTION TO APPOINT A  
2021 ADVISORY TRI-COMMUNITY RECYCLING AD HOC COMMITTEE**

At a regular meeting of the City Council for the City of the Village of Douglas, Michigan, held virtually by Zoom, on the 4<sup>th</sup> day of January 2021 at 7:00 p.m.

Council Member Seabert, offered the following resolution and moved for its adoption, seconded by Council Member Mooradian:

**RESOLUTION**

**WHEREAS**, the governmental bodies of the City of the Village of Douglas, City of Saugatuck, and Saugatuck Township (“Communities” or “Community” as appropriate) support general recycling efforts; and

**WHEREAS**, issues with recycling contamination and vulnerability of markets for recycled materials have created recycling challenges statewide; and

**WHEREAS**, the Communities have identified a need for better education and processes to enhance and maximize recycling activities in the most cost effective manner to the public; and

**WHEREAS**, the Communities have identified collaborating together by establishing an ad hoc committee would be an appropriate step to identify and address critical recycling issues; and

**WHEREAS**, per Section 7.14 (c) of the City of Douglas Charter, the Council may create other public authorities, boards or commissions or other entities to meet community needs.

**THEREFORE, BE IT RESOLVED** the Council does hereby authorize the creation and appointment of members to serve on a 2021 Advisory Tri-Community Recycling Ad Hoc Committee (“Committee”) as follows:

1. Each of the three Communities will be allowed to appoint up to 3 members to represent their jurisdictions.
2. Appointees may be elected officials and/or non-elected.
3. The City of Douglas appoints Cathy North, Ronna Alexander, and Demetrhea Terrine.
4. The Committee will be charged with identifying a list of objectives to research and prepare a report outlining any recommendations back to each unit of government.

5. The Committees actions shall be advisory in nature only.
6. The Council does not delegate any authority to the Committee to make decisions on behalf of the Council.
7. The Committee shall terminate on December 31, 2021 unless otherwise extended by Council via resolution.

**NOW BE IT RESOLVED** that the City of the Village of Douglas City Council does hereby adopt Resolution 01-2021 and appoint Cathy North to the 2021 Advisory Tri-Community Recycling Ad Hoc Committee.
