#### A RESOLUTION TO ESTABLISH "BLUE STAR CORRIDOR FUND"

At a regular meeting of the City Council for the City of the Village of Douglas, Michigan, held at the City of the Village of Douglas City Hall, Douglas, Michigan, on this 17th day of January, 2022 at 7:00 p.m.

The following Resolution was offered by Councilperson Seabert and supported by Councilperson Miller.

#### RESOLUTION

WHEREAS, the Michigan Department of Treasury provides to the City of the Village of Douglas annual payment of marijuana funds ("MRE revenue") collected pursuant to the Michigan Regulation and Taxation of Marihuana Act (Initiated Law 1 of 2018) and the Medical Marihuana Excise Fund (Section 2 of 2016 Public Act 281); and,

WHEREAS, MRE revenue is allocated by the State for the period of October 1st though September 30th annually, in proportion to the number of licensed marijuana facilities, retail stores, and microbusinesses located within the municipality; and,

WHEREAS, the City provides license to two (2) sites for marijuana facilities/retail stores

located in the C-2 General Commercial District, on properties adjacent to Blue Star Highway;

and,

WHEREAS, resultant of these two (2) sites, the City of the Village of Douglas posted

to the general fund \$28,001.32 ("FY20 MRE #032015", Check/EFT No: 3011303642,

03/03/2021) in MRE revenue from the State; and,

WHEREAS, the City of the Village of Douglas has established goals and objectives of

the "Our Douglas Vision" Master Plan and the Blue Star Corridor Plan mandating physical

safety, aesthetic, environmental, and economic improvements to the Blue Star Highway

Corridor that shall require significant planning/engineering services and continued capital

investments; and,

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS: The City of the Village of

Douglas shall establish a Blue Star Corridor fund, for the immediate allocation of FY20 MRE

#032015 and annual allocation of future MRE revenues as expected expenditures, for

planning/engineering services and capital improvements that accomplish the goals and

objectives of the Blue Star Corridor Plan.
