RESOLUTION

WHEREAS, placemaking is the process of creating quality places that people want to live, work, play and learn in; and,

WHEREAS, the creation and maintenance of quality places provides for economic, social, and cultural exchange among people, business, and institutions; and,

WHEREAS, the City of the Village of Douglas "Our Douglas Vision" Master Plan, Downtown Development and Tax Increment Financing (TIF) Plan, and Blue Star Corridor Plan establish goals and objectives of the City consistent with placemaking; and,

WHEREAS, connectivity to and activation of the waterfront and Blue Star Highway through placemaking is vital to the Downtown District;

WHEREAS, the City of the Village of Douglas Downtown Development Authority (DDA) allocated \$18,000.00 toward capital improvements and beautification of the Gateway Sub Area in FY2021-2022 -intended for a mural/public art to further-activate Center Street and Blue Star Highway through placemaking; and,

WHEREAS, the DDA seeks partnership with the City to cost share and collaborate to achieve master planning objectives related to physical safety, aesthetic, environmental, and economic improvements to the waterfront and Blue Star Highway Corridor; and,

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS: The City of the Village of Douglas shall approve of 880 Community Promotions Request, awarding \$20,000.00 to the Downtown Development Authority (DDA) Mural Program, amending the FY21-22 budget, reserving all agreements and contracts for the review and approval of City Council.


