BULK TRASH PICK-UP RULES

- THE PICK-UP IS LIMITED TO 3 CUBIC YARDS PER DWELLING UNIT - APPROXIMATELY EQUAL TO A PICKUP TRUCK BED.
- SMALLER ITEMS NEED TO BE PLACED IN CLEAR, HEAVY-DUTY PLASTIC BAGS OR OPEN CONTAINERS. MUST BE ABLE TO SEE EACH ITEM TO DETERMINE IF IT QUALIFIES FOR PICKUP.
- **ALL ITEMS MUST WEIGH LESS THAN 50 POUNDS.**
- ITEMS TO BE PLACED AT CURB NO EARLIER THAN MAY 31.
- ITEMS PLACED OUT AFTER JUNE 5 WILL NOT BE PICKED UP. ADDITIONAL PICK-UPS WILL NOT BE SCHEDULED.
- DO NOT BLOCK THE ROADWAY.

Acceptable items for pick up:

- Mattresses - **must have a cover**
- Furniture under 50 pounds
- Toys
- Appliances (i.e., mini refrigerators, air conditioners) *Freon must be removed, and the item must be tagged by a licensed facility showing that the freon has been removed. Please remove refrigerator doors or wire shut for safety reasons.*
- Home fixtures and other items that are not considered hazardous.
- Small amounts of building materials *such as doors (limit 2) and fencing- material needs to be cut down small enough to fit into the truck (4 FT long and bundled and tied) and be lifted by one person.*
- Latex paint - *paint must be dried in containers (use sawdust or kitty litter)*
- Small car parts
- Manageable bundles and containers. *DPW employees will not unload items from trailers.*

Unacceptable items for pick up:

- **NO** Black Trash Bags - **clear bags only.** *Items must be visible.*
- **NO** windows or glass
- **NO** large plastic or metal drums
- **NO** concrete
- **NO** large pieces of metal
- **NO** yard waste
- **NO** liquid waste or hazardous waste
- **NO** tires or tires on rims *(may be acceptable if cut up into flat pieces)*
- **NO** non-latex paints and varnishes
- **NO** motor oil, batteries, and solvents
- **NO** regulated medical waste
- **NO** free-flowing liquid *that has not been solidified*
- **NO** large car parts *such as engine blocks, bodies, oversized hoods, and doors*
- **NO** building demolition material - *large volumes of demolition debris that would normally require a construction-style dumpster cannot be taken.*
