

City of the Village of Douglas Administration Report Week of April 7th-18th, 2025

Ferry Street Culvert Project Update –Here's what's happening on-site as we close out the week of April 18: Frontier has reinstalled their three fiber lines back on the poles, saw cutting of damaged pavement areas was completed, and the sand subbase and aggregate base grading are now done. Side slope stabilization using riprap is also finished. If the weather permits, base course asphalt paving may even happen on Friday, April 18th, 2025.

Looking ahead to the week ending April 25: Comcast is planning to reinstall their fiber line on the poles, and if paving can't happen today, both base and top course asphalt paving will occur next week. Guardrail installation, shoulder aggregate placement, and final side slope and topsoil restoration are also scheduled.

The week after (ending May 2), pavement markings and pedestrian crossing delineators are expected to go in, along with final site restoration, all weather dependent. We're still on schedule, and if Mother Nature cooperates, the contractor believes Ferry Street could reopen in early May. We'll keep you posted as this rainy April/early May plays out!

Public Notice: Please Plan Ahead- Notice of Road Closure/Construction on Wiley Road: Please do not attempt to access Blue Star Highway or Wiley Road through the 415 Wiley property. There are construction teams working all around the property, and we want to ensure their safety during the Fire Suppression connection work.

AN IMPORTANT UPDATE FROM MICHIGAN GAS UTILITIES: Please contact MGU Directly with any questions.

Michigan Gas Utilities (MGU) has visited all the customers in Allegan County who lost service last week. Crews have restored service to more than 80% of customers and left information for the remaining customers who were not at home.

On Monday, utility crews are again going door to door to the remaining customers who were not available during the first visit.

We believe there are hundreds of homes that are summer homes or second homes where the customer may not be regularly available. In those cases, we would ask the homeowner to work with a trusted neighbor to let our crews access the home to restore service and relight appliances.

MGU is keeping extra crews in the area this week to help restore service to the remaining customers as quickly and safely as possible.

The MGU pipeline lost natural gas service on April 9 when the natural gas transmission pipeline line that serves MGU was damaged.

The transmission pipeline operator, TC Energy, worked around the clock to repair the damage to their pipeline. The damage was caused by a third party unaffiliated with MGU or TC Energy.

Service was restored to the MGU pipeline on April 11. Utility crews have been working around the clock since the initial incident to safely secure the MGU distribution system and restore service to the 5,200 customers impacted.

We appreciate customers' patience and all the kind words and gestures from the community. From the thank you messages and hand waves to food and water drop offs, we are grateful.

Road Projects Approved for FY24/25:

The scope of work is to mill and overlay:

- Wiley Road from Blue Star Highway to approximately 360' West (scope to include storm drainage work)
- Fremont Street from Union Steet to pavement change by Spring Street
- May Street from Center Street to pavement change by First Street

Douglas Marina Park: The City of the Village of Douglas was awarded a \$100,000 grant from the Consumers Energy Foundation to support the construction of a pavilion and an accessible path at the Douglas Marina Park.

In addition to this generous grant, Douglas residents Bud Baty and Max Matteson have offered to match the grant funding and, if necessary, raise additional funds to include a restroom with a shower and a community fire pit as part of the park improvements. Architectural drawings for the expanded amenities were submitted by Baty and Matteson and reviewed by the City Council on April 7th. The renderings can be accessed by visiting the city website under agendas and meeting notices (April 7th City Council meeting). The city will now work on issuing a request for proposals separately for the pavilion and restroom.
