OTSEGO PUBLIC SCHOOLS GENERAL OBLIGATION UNLIMITED TAX BOND PROPOSAL FOR BUILDING AND SITE PURPOSES IN THE AMOUNT OF NOT TO EXCEED \$46,500,000. This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance and renews millage that will expire with the 2025 tax levy. Shall the currently authorized millage rate limitation of 18.6727 mills (\$18.6727 on each \$1,000 of taxable valuation) on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Zeeland Public Schools, Ottawa and Allegan Counties, Michigan, be renewed for the year 2026, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2026 is approximately \$11,355,713 (this is a renewal of millage that will expire with the 2025 tax levy)? **OTTAWA AREA INTERMEDIATE SCHOOL DISTRICT SPECIAL EDUCATION MILLAGE PROPOSAL** This proposal will allow the intermediate school district to continue to levy the special education millage previously approved by the electors and restores millage lost as a result of the reduction required by the Michigan Constitution of 1963. Shall the currently authorized millage rate limitation of 1.2425 mills (\$1.2425 on each \$1,000 of taxable valuation), on the amount of taxes which may be assessed against all property in Ottawa Area Intermediate School District, Michigan, to provide funds for the education of students with a disability, be renewed for a period of 18 years, 2027 to 2044, inclusive, and also be increased by .5000 mill (\$0.5000 on each \$1,000 of taxable valuation) for a period of 20 years, 2025 to 2044, inclusive; the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2025 is approximately \$4,545,865 from local property taxes authorized herein (this is a renewal of millage that will expire with the 2026 tax levy and a restoration of millage lost as a result of the reduction required by the Michigan Constitution of 1963)?
